

AEB 5326 Agribusiness Financial Management Fall Semester 2023

AEB 3122 or ACG 2071 (or equivalent).

Course Objective

This course aims to provide a basic understanding of corporate finance principles and build a foundation for other agribusiness courses. The course gives students the tools to understand and solve essential financial problems farms and agribusinesses face today. Practical applications and problem-solving techniques are emphasized. The topics covered include financial statement analysis, time value of money, valuation of financial assets, investment frameworks, capital budgeting techniques, and capital structure theory.

The course will be delivered via Canvas/Zoom. Some lectures will be video recorded, and the instructor will share with students a link to access the video/lecture if needed. In addition to PowerPoint and Excel files to support the lectures and discussion, the instructor plans to use software (Goodnotes) as a virtual "whiteboard" during the lectures.

Exams:

We plan to have three "in-class" exams during the semester. Each exam will have the same weight/value, meaning that the average of the three exams will be worth 40% of your final grade. The exams will be 'closed-book/notes" exams administrated via Canvas using Respondus / LowDown Brower + Webcam or similar software. Given the asynchronous nature of this course, the exam will be made available to students during one complete day so that they can complete it at their convenience.

The in-class exams will include all topics covered throughout the term and content from the homework assignments. In particular, the test will cover content from the reading materials and the "lectures." Regarding the format or structure, the in-class exams might include multiple choice, false or true, numerical calculations, and essay types of questions.

You will be <u>confirmed</u> at least one week before each term exam date.

Homework assignments:

We plan to have from three to five homework assignments throughout the semester. Each homework assignment will have the same weight/value, meaning the average of all assignments' grades is worth 60% of your final grade. The homework assignments will consist of solving case studies or problem sets or practicing/replicating a financial technique feature in course materials or discussed in lectures. Homework assignments will be due before the in-class exams. Thus, they should allow students to work with the relevant content covered during the term and prepare themselves for the in-class exams.
